#### 1. Call to Order

White generously donated the time of one of their carpenters to build an art easel and sound wall which has been installed in the Learning Area. We will be recognizing them for their contributions. Fencing has been installed. Continued collaboration will occur as we decide on additional learning resources to be added to the area later in the school year.

# c) Section 68 Annual General Meeting

M. Wilcox shared that at the May 2023 Annual General Meeting, it was determined that the May 2024 Annual General Meeting would be hosted by JMCCSA.
